## Maintenance Report: Mathieu Rose

**Mathieu Rose** gave an overview of the system for January 2024 with a completion of 198 Work Orders, 8 Leaks repaired, 3 Precautionary Boil Advisories cleared with one leak pending.

He discussed the Singer Plant PSI & Well controller continuously failing. He has reached out to BECI and requested an outage, and download report to see what is going on. Last year 4 of the controllers burnt up. The last controller is being sent back to the manufacturer to see if there is a defect. It is an ongoing process to see what the issue is. There has to be a solution to this problem, and he is reaching out to all resources available with hopes of a resolution.

**Mathieu** further discussed initiating an annual preventive maintenance program to have a pump test on each Well. He submitted a proposal by Layne Christensen to do a flow pump test every 1-3 years at \$1,500 per Well. The initial proposal included the flow test, and maintenance to replace the motor on Well 3 in the amount of \$6,000.00

**Mrs. Richelle Bowman**,  $2^{nd}$  by Mr. Caroll Johnson, moved to accept the initial proposal to flow test all 4 Wells, and to replace the motor on Well 3 in the amount of \$6,000.00. The motion carried without opposition.

**Mr. Bill White** said that he had someone to come look at the shops on Stanley Smith Road to raise the floors, which will be the first step in solving the drainage problem.

There was a discussion on where to store the materials while the slabs where being poured, and Mr. Jerry Cooley, suggested renting a storage container to house the material and supplies until the floor is completed.

Mr. Mathieu Rose stated that if a storage unit was not rented, there was no where else to put them but outside. No, decision was made on renting the storage unit for materials.

There being no further business, Richelle Bowman,  $2^{nd}$  by Bill White, moved to adjourn the meeting, the motion carried without opposition.
